Lou Jacobs Award 2026

In 1972 our Association adopted a policy of giving special recognition to persons who have made outstanding contributions to rural government and community life in Saskatchewan. The **Lou Jacobs Award** is used as a vehicle for providing this recognition and it serves the dual purpose of also honouring the late Lou Jacobs for his valuable and dedicated service in the Department of Municipal Affairs for so many years. The bylaws of the Association provide that the recipient of this award be granted honorary life membership in the Association. In adopting the program of making this award available it was stressed that it be a very special honour, with not more than one such presentation each year. However, the name of the nominee may be submitted in subsequent years if he or she is not selected on the first submission. If you wish to nominate anyone for this award, please send your nomination to me as soon as possible, but not later than **February 15th**. A brief biography of the municipal career, activities and special accomplishments relating to municipal affairs and community life in Saskatchewan, should accompany each nomination. 2026 RMAA Membership Dues

For **2026** - The Regular Membership fee for active members (certificate holders only) is \$425.00 while Associate Membership has changed to **\$225.00** (non certificate holders). We have enclosed a separate membership invoice as part of your package. **NOTE:** Only regular members are granted voting privileges. Active Administrators **must** purchase a regular membership. Certificate holders who work in the office but are not active Administrators **may** purchase either a regular or associate membership. It is expected that all certificate holders that are not practicing Administrators, and those wishing to be placed on the relief list, purchase at least an associate membership. Retired members are encouraged to purchase an associate membership. This is the only notice you will receive for RMAA Membership dues! Receipts will be issued to the party whose name is on the cheque and will only be issued upon request. We want to acknowledge and thank Councils for recognizing that the RMAA member fees fund valuable committee work that not only benefits Administrators but also benefits the Councils and ratepayers that our members serve!

Bylaw 1

The RMAA Executive is proposing some changes to Bylaw 1. These changes are outlined on page six of this newsletter. The reason for the proposed change is to clarify the eligibility for an associate membership. The Executive recognizes the importance of learning opportunities for all administrative staff to better serve their municipalities. Once this change is made in the bylaw it is intended that an associate membership will be required for attendance at the annual convention.

2025 has been another busy year for the Rural Board of Examiners.

There are currently 17 RM's operating under Acting Administrator Permits

19 applicants have received their Rural "C" Certificate so far in 2025

15 Administrators received their Rural "A" certification in 2025

2 Administrators received their Superior "A" certification in 2025

Congratulations to you all!!

In total in 2025, 20 administrators applied for "A" or Superior "A" certification, and 17 were awarded their certificate, for an 85% success rate.

The BOE processes advanced applications twice a year. The deadlines to apply are March 1st and September 1st each year. *Please note, due to tight processing timelines, applications must be received by the BOE Secretary by those dates (not post-marked by the deadline). Late applications may not be accepted.*

In order to qualify for Rural "A" certification, an application must:

Have had their Rural "C" Certificate, and worked in the role of the Administrator for two consecutive years

If the applicant has relocated offices since obtaining their Class C certificate, they must have worked for two calendar years at their current office location prior to applying.

In order to qualify for a Rural Superior "A" certification, an application must:

Obtained a higher level of post-secondary education as outlined within the Rural Board of Examiner Regulations

Have had their Rural "A" Certificate, and worked in the role of the Administrator for five consecutive years

If the applicant has relocated offices since obtaining their Class "A" certificate, they must have worked for three calendar years at their current office location prior to applying.

What is AMP:

- ◆ AMP is confidential on-site time with an experienced RM administrator visiting you at your office, spending the day together, reviewing your work, office setup, and answering questions regarding the responsibilities, duties, and tasks of the administrator role and profession.
- ◆ An experienced set of eyes; a mentor will reiterate and provide assurances of work you are doing well.
- ◆ They will provide suggestions regarding best practices, and catch potential duties that are being missed, or could be done differently.
- ◆ Office visits are scheduled between yourself and the AMP Mentor at a time that is convenient to both parties.
- ◆ There is currently no additional cost to you, or your RM to participate.
- ◆ Office visits are kept confidential between yourself, and the AMP staff.
- ◆ The program is not designed to provide an opinion of your abilities as an administrator, but as a support tool our association is providing its members.
- ◆ AMP is open to ALL working RM Administrators, it is especially recommended for administrators holding a Rural “C” Certificate who have not yet obtained their “A”.

Proposed Amendment to Bylaw 1

Classes of Membership:

The following shall be the classes of membership in the Association:

ACTIVE MEMBERSHIP: Shall mean all practicing Rural Municipal Administrators, ~~Secretary Treasurers~~ or Assistant Administrators ~~or Assistant Secretary Treasurers~~, and as more fully contained in Subsection 1 of Bylaw No. 1. Active members shall have all voting and all other privileges as contained in the bylaws of the Association and shall be the only class eligible to be elective officers.

ASSOCIATE MEMBERSHIP: Shall mean Non-practicing Rural Municipal Administrators, ~~assistant administrators and all other administrative staff employed by a rural municipality or Secretary Treasurers~~ may enroll as associate members of the Association by paying annually associate membership fees as set by the association. Associate members shall not have voting privileges nor be eligible as elective officers.

HONORARY MEMBERS: Shall mean recipients of the Lou Jacobs Award and shall be granted Honorary Life Membership in the Association. Honorary Life membership may be bestowed on other persons by the annual convention of the Association. Honorary Members pay no membership fees to the Association. An Honorary member, unless an active member, shall not be eligible for voting privileges or to be an officer of the Association.

BYLAW No. 1, A BYLAW OF THE RURAL MUNICIPAL ADMINISTRATORS' ASSOCIATION OF SASKATCHEWAN PROVIDING FOR MEMBERSHIP IN THE ASSOCIATION:

1. Any person 18 years of age or over and of good moral character who holds a valid certificate of qualification issued by the Board of Examiners, appointed by the Department of Municipal Government, and who is currently employed as the Administrator or Assistant Administrator of a Rural Municipality may apply for active membership in the Association. No person shall be admitted as an active member who does not hold such a certificate.
2. An application for active membership shall be on a form prescribed by the Association and shall be accompanied by the annual membership fee. An application for Associate Membership shall be on a form prescribed by the Association and shall be accompanied by the annual Associate Membership Fee.
3. The Immediate Past President of the Association and, subject to the approval of The Saskatchewan Association of Rural Municipalities, the President of that Association, shall be ex-officio members of the Association. The Association in annual convention may admit, as honorary members, such persons as the convention shall approve. Non-practicing Administrators, ~~assistant administrators and all other administrative staff employed by a rural municipality who are otherwise qualified~~ may be admitted as Associate Members upon payment of a special annual fee to be set by the Executive Board, provided that such Associate Members shall not have voting privileges at the Annual Convention of the Association. Each recipient of the Lou Jacobs Award, shall be granted Life Membership in the Association.
4. If the applicant ~~meets eligibility criteria holds the necessary certificate~~ and complies with the requirements as to payment of the membership fee he/she shall be admitted to membership in the Association and the Association shall issue to the applicant a Certificate of Membership in the Association.
5. Certificates of membership shall expire on the 31st day of January each year and on expiration thereof, all rights of membership in the Association shall cease and determine unless prior to the said date the holder of a certificate of membership shall have paid to the Executive Director of the Association the annual membership fee for the then current year as well as any other fee payable under the bylaws of the Association.
6. The name of the Association shall not be used by any member or group of members without permission in writing from the Executive Board.
7. All active Association Members shall participate in S.A.R.M.'s Long Term Disability Plan unless specifically exempted by the R.M.A.A. Executive Board.
8. All active Association Members shall participate in S.A.R.M.'s Mandatory Group Life Insurance Plan unless specifically exempted by the R.M.A.A. Executive Board.
